on any Windows machine with an installed version of Adobe Photoshop. If you are not running the latest version of Adobe Photoshop you can install the Photoshop elements software on a machine that does have Photoshop installed. Unlock and run "Adobe Photoshop Elements 2015"

Download the program to your computer If you're installing it on a Windows machine, you have to download the program. If you're installing it on a Macintosh, you can download it from Apple's App Store.

After you have downloaded the program, restart your computer and launch Photoshop Elements. The Photoshop Elements page will open

and you can install it there. You can install a version that is compatible with a single Photoshop edition, or you can install both Photoshop and Photoshop Elements. When you're done installing the program, the "Start" button should be selected.

The law is well settled that where compensation is required for property damage, the carrier must give notice of the loss or damage to the owner within 24 hours after the occurrence of the loss or damage, and the injured person or the person damaged must file his claim with the carrier within one year from the date of the loss or damage. It is also well settled that when such notice is received by the carrier, or such claim is filed, the carrier is then liable to pay the difference between the actual value of the property at the time of the loss or damage and the value it

would have had if it had been in the condition it was prior to the loss or damage. \*98 The employer and the carrier entered into a written agreement on February 7, 1944, which provided that the compensation should be paid for personal injuries to or death of employees who were covered by the act. This agreement was in force at the time of plaintiff's injury on July 28, 1945. Pursuant to the terms of this contract and the statute the employer and the carrier paid plaintiff compensation for 31.25 weeks of temporary total disability, and \$20 a week for 4 weeks of total permanent disability, making a total of \$1,948.50, which

High-efficiency perovskite/graphitic carbon nitride nanocomposites as high-performance counter electrodes for dye-sensitized solar cells. Herein, we report the high-efficiency counter electrode (CE) for the dye-sensitized solar cells (DSSCs). The high-efficiency counter electrode (CE) was fabricated through the direct deposition of ultra-thin graphitic carbon nitride (g-C<sub>3</sub>N<sub>4</sub>) on a fluorine-doped tin oxide (FTO) electrode by a simple solution process. The g-C<sub>3</sub>N<sub>4</sub> nanoparticles were coated on the FTO electrode

---

by chemical vapor deposition (CVD) and a substrate. Then, the g-C<sub>3</sub>N<sub>4</sub>/FTO electrode was applied to the DSSC fabrication. The performance of the DSSC was enhanced from 4.31% to 8.26% after directly coating the g-C<sub>3</sub>N<sub>4</sub> on the FTO electrode. The nitrogen content of the g-C<sub>3</sub>N<sub>4</sub> enhanced the environmental stability of the g-C<sub>3</sub>N<sub>4</sub> nanoparticles under the acidic and basic media, and the enhanced conductivity of the FTO electrode through the g-C<sub>3</sub>N<sub>4</sub> nanoparticles. This study demonstrated that this proposed approach is a promising method to fabricate a high-performance and stable CE of DSSC.
